FREQUENTLY ASKED QUESTIONS AND ANSWERS SHEET

MONTENERO AT PELICAN BAY CONDOMINIUM ASSOCIATION, INC. As of January 1, 2025

- Q. What are my voting rights in the condominium association?
- A. Each unit in the Condominium will have one full indivisible vote in all Condominium Association matters.
- Q. What restrictions exist in the condominium documents on my right to use my unit?
- A. Unit use is limited to residential purposes. Quiet, inoffensive household pets including 1 dog (no more than 15" tall at the shoulder at maturity), or 2 cats and tropical fish are permitted. Guests must be registered with the Manager. Please refer to the Association Rules and Regulations Section 32.
- Q. What restrictions exist in the condominium documents on the leasing of my unit?
- A. All leases must have the prior approval of the Association. Units may be leased for a minimum of 90 days and not more than 1 time per year. Please refer to Section 24 of the Association Rules and Regulations.
- Q. How much are my assessments to the condominium association for my unit type and when are they due?
- A. The estimated operating budget figures are as follows for the various unit types. The figures below include the Reserve Contribution.

- A. Yes. You are automatically a member of The Pelican Bay of Naples Foundation, Inc. with voting rights of one vote/unit. There is a \$2,675.00 assessment per year (includes annual internet service & basic cable TV service) which are subject to change annually. Please refer to The Pelican Bay Foundation documents.
- Q. Am I required to pay rent or land use fees for recreational or other commonly used facilities?
- A. No. Use of these facilities is included in the Pelican Bay of Naples Foundation membership.
- Q. Is the condominium Association or other mandatory membership association involved in any court cases in which it may face liability in excess of \$100,000.00? If so, identify each such case.
